

Notice To All Public Officials:

The bearer of this form does hereby lawfully notify you that you are commercially liable for any violation of his or her rights, and that the bearer:

- 1) Reserves all religious, constitutional, civil, human, and sovereign rights.
- 2) Reserves the constitutional and human right freedom of movement as confirmed in the New Zealand Bill of Rights Act 1990, Part 2 18 '*Freedom of movement*'.
- 3) Will not consent to any search of their body or property or any testing, finger-printing, or the taking of DNA samples.
- 4) Will not answer any questions before completion, by the public official of a 'Public Servant Questionnaire pursuant to the New Zealand Privacy Act 1993 Part 2, 6 '*Information privacy principles*'.
- 5) Will hold liable under full commercial liability for damages through civil suit any public servant who deprives them, howsoever, of their reserved rights as herein declared.

Public officials who violate their oath to serve “**according to the law**” may be liable for civil suit, criminal charges, and class actions.

FEE SCHEDULE:

NZ\$10,000 per violation of my innate rights, including freedom of movement as a natural right, not a legally granted privilege, and my right to contract with free and genuine consent, while conducting my private life peacefully and according to the Law of the Land.

Lawful: Law of the Land, Trial by Jury, Case Law, created by the people, concerned with right and wrong, and the provision of justice to living humans. Of Common Law. *De jure*.

Legal: Legislation, Statutes, Acts of Government, to govern artificial legal person, containing the rules and regulations of statutory contracts. Of Commerce. *De facto*.

Maxim in Law: *Consent makes the law. A contract is a law between the parties, which can acquire force **only by consent**.*
